TERMS OF USE

Site ownership; Agreement to Terms of Use

10. GOVERNING LAW

10.1. The interpretation and performance of these Terms of Use will be governed by and construed in accordance with the laws of Malaysia, without regard to any conflicts of law principles that would require the application of the laws of any other jurisdiction.

11. DISPUTE RESOLUTION

- 11.1. Any controversy, claim, or dispute related to these Terms of Use (including incorporated terms) must be resolved through panel arbitration administered by Asian International Arbitration Centre ("AIAC") following its AIAC i-Arbitration Rules (the "Rules").
- 11.2. In the event a court deems this arbitration requirement unenforceable, or if a court proceeding is permitted by a competent jurisdiction or leave of courts in Malaysia, the Parties explicitly consent to the exclusive jurisdiction of the courts in Malaysia. Thus, any legal action initiated by either Party against the other Party for claims arising from these Terms of Use shall be brought in the Malaysian's courts, or federal courts if applicable, of Malaysia. Except as specified in these Terms of Use, the schedule and rules for the arbitration hearing shall be determined by the arbitration panel ("Panel") appointed by AIAC following the Rules. The location of the arbitration shall be Kuala Lumpur, Malaysia.
- 11.3. Notwithstanding to the above, the Parties agree to the following: -
 - 11.3.1. Each Party will cover its own costs and fees associated with the arbitration, except for the arbitrators' fees, which will be shared equally by both Parties;
 - 11.3.2. Any decision made by the Panel will include a written opinion explaining the rationale for the decision;
 - 11.3.3. The Panel cannot award punitive, consequential, or exemplary damages;
 - 11.3.4. This provision and the arbitration process will be governed by Arbitration Act 2005;
 - 11.3.5. The Panel's decision must be based on these Terms of Use and applicable law, will be final and binding with no right of appeal except for cases of fraud, misconduct, or legal errors, and the decision can be enforced in any court with jurisdiction/ Malaysia; and

- 11.3.6. No arbitration can proceed on a class basis or be joined or consolidated with another arbitration. If the prohibition in this Clause 11.4.6. is deemed unenforceable, then neither party will be required to arbitrate. Even if applicable law or regulation allows for class actions or class arbitrations, the dispute resolution procedure specified here applies, and GoHub and Customer waive any rights to pursue any claim arising under or related to these Terms of Use on a class basis.
- 11.4. Despite the above, the Parties understand and agree that any dispute concerning the title, use, validity, or other similar claims related to intellectual property, including copyright, trademark, patent, or trade secrets, and Confidential Information will not be subject to the arbitration provisions in this Clause.
- 11.5. This Clause will not restrict a party's right to seek or obtain provisional or preliminary relief from a court of competent jurisdiction to: -
 - 11.5.1. Compel arbitration according to these Terms of Use;
 - 11.5.2. Obtain orders to require witnesses to comply with subpoenas issued by the arbitrators;
 - 11.5.3. Request temporary injunctive relief related to the breach of the other Party's confidentiality obligations under these Terms of Use; or
 - 11.5.4. Ensure the enforcement of any arbitration award rendered in accordance with these Terms of Use.

12. Severability; Entire Agreement

12.1. If a competent legal authority deems any part of these Terms of Use illegal, invalid, or unenforceable for any reason, it shall be modified to the extent necessary to make it enforceable while keeping the remaining provisions in full force. These Terms of Use (i) represents the entire understanding between the Parties regarding its subject matter; (ii) supersedes any prior agreements or understandings that are not included herein; and (iii) includes all terms, conditions, understandings, and representations of the Parties.
